VFW Parking Lot No Longer Open to Public

The city of Woodstock's 20-year lease with the Woodstock VFW parking lot on Throop Street expires Wednesday, September 1st and will not new renewed. The VFW will supervise its area of about 35 parking spaces, the northern one-third of the current Throop Street parking lot, for exclusive use by VFW members, patrons and guests.

Ralph Ritter, VFW member, said, "Our membership is getting older. Many are using canes and walkers."

He added that he believes more members will attend VFW events if they can park in the VFW lot.

"The city assisted us by putting a crosswalk from the Metra lot at Throop and Washington streets," he said. "However, this is still a long walk for some members and requires crossing Throop Street," he added.

Ritter said the VFW is excited about reserving parking spaces near the building for VFW members, patrons and guests.

Ritter is working on plans to place a small barrier between the VFW lot and the city lot, which is adjacent to the Chop Suey Hut. Ritter said stripes on the VFW lot will be painted blue to further identify the lot as a private area.

"Official signs will be posted to mark the private parking area and announce that unauthorized vehicles will be towed," said Ritter.

Ritter said the stairs that lead from the parking lot to the gas station at Washington and Main streets also will be closed.

City officials explored the possibility of purchasing the VFW building and parking lot. Both parties obtained appraisals. A wide difference of opinion on the value of the property terminated the discussions.

Sweetheart Raffle - Increase Your Odds Of Winning Some Prize Money

By now you have heard the VFW promoting the Sweetheart Raffle in the last few issues of the VFW News. One of the reasons for this raffle is the need for additional funds for our post. We are simply running out of money. That's why this raffle is so large and why we are pushing so hard for it.

Okay. You might be saying to yourself, "\$50.00, that's a lot of money". But don't forget, the prizes are \$5000, \$3000, \$2000, and \$1000. Only 1000 tickets and 4 large prizes. That's a 1 in 250 chance of winning 30,000 one of the prizes. Want to make these odds even better? You can! But the portion of the winnings decreases.

Here's how: create a ticket pool! Get several friends and/or family members to each buy a ticket, then put all buyer's names on every ticket. Easy as that. Think of it as an office lottery pool where co-workers \$20.000 put money into a pool and then buy a bunch of tickets to increase their odds.

Here's an example. Say you have 2 friends, and each of you buy a ticket and all 3 names go on each ticket. That's 3 tickets. The odds now are 1 in 83 of you winning something. If one of you won the \$1000 prize, divide that 3 ways and each of you walks with \$333.33. If one of you Sales to date: won the \$5000 prize, divide that 3 ways and each of you get \$1666.67. How do you \$7.800 like that? Want even more odds? Try getting 5 people from work or your immediate family to each buy a ticket and put everyone's name on each ticket. Odds now are 1 in 50 that you will win something. If one of you won the \$1000 prize, divide that 5 ways and each of you walks (1) with \$200.00. If one of the tickets won the \$5000 prize, divide that 5 ways and each of person gets \$1000.

One last thought. Each ticket can only win one cash prize. But think about it. Say you are in a pool of Raffe Raffe of 3 people. If by luck of the draw, one of those 3 tickets won the \$5000 prize and another won the \$3000 prize, that would be \$8000 split 3 ways...\$2666.67. So, what are you waiting for? Go out and get some people together and buy some tickets. Get a pool going and you just might walk away with a nice chunk of cash.

Thanks For the Help at Fair and Airport



Help is needed regarding your Woodstock *VFW NEWS*. Quit a few copies are being returned by the post office marked "Temporarily Away." How are we to know when you will return? Because you don't let us know we withhold mailing until a later month when we hope you may be home.

Each undeliverable copy costs the VFW an additional 37 cents. Arrangements you make with the post to handle your mail while you are gone do not apply to the *VFW NEWS*. Therefore, you must notify us by mail, e-mail, or call 815-338-5040 and tell us whether to hold your *VFW NEWS* for later mailing.

If you are going to be gone for several months (that is, during the winter months), give us your temporary mailing address well ahead of your departure, with your departure date and your returning date. We'll mail it where you want us to send it. In addition, if you are moving to a new address, get it to us as soon as possible, so we can get it into the computer for the next mailing.

Don't forget, if you have access to a computer, you can also download the latest copy of the *VFW NEWS* and save the post ever more postage.
