Dedicated Post member Bob Gaylord, has died

Robert Gaylord, 86, was honored at the Woodstock VFW with a memorial service in celebration of his life Sunday, March 29. Gaylord, World War II Army veteran in both the European and Pacific Theaters, died Sunday, March 15 at Lasata Nursing Home in Cedarburg, Wisconsin.

Bob and his wife Patricia Kennedy Gaylord were married 61 years. Both Bob and Pat were among leaders in serving veterans through a great many hours of volunteer activity and service. They were among the first and most consistent to supervise and organize Soup to Nuts, a successful fundraising activity helping residents dispose of good merchandise of many categories.

To observe Bob and Pat in action was to know the tremendous amount of work involved in a successful fundraising activity. Bob and Pat also worked as waiters in serving VFW dinners and banquets. This labor of love extended for a great many years, up to recently when declining health put a stop to his ability to serve others

A memorial service was held at Oakland Cemetery on Sunday, March 29. This was followed with a reception at the VFW and a tribute and luncheon at the Post Home.

Three children survive including Kim (Mark) Meisinger, Leigh (Carmelo) Raffaele and Jill Gaylord. Erica and Dominic Raffaele are surviving grandchildren.

His military record shows he enlisted February 12, 1943 and discharged March 10, 1946. He received the European African Middle Eastern Campaign Medal with a Bronze Battle Star and an Asiatic Pacific Campaign Medal and a Good Conduct Medal during World War II.

Recently it was reported that the VFW changed out all of the ceiling lights in the lower hall with the new CFL bulbs. This amounts to a savings of over \$250 per year in electricity. Total wattage use went from 2085 to 690 (46 bulbs) watts.

VFW Post 5040 nominations and elections for 2009-2010 Officer positions held in April

We are coming into that time of year when it's time to start thinking about our next year's officers and who will be leading our Post.

At the March meeting, VFW Judge Advocate, Dick Glawe, and 3 Year Trustee, Arnie Doerfert, were appointed as the VFW election officials for the upcoming VFW Elections. Election will take place at the April meeting.

Of the nominations that were made at the March meeting, only two positions were open that no one was nominated for, Service Officer and Quartermaster.

As traditionally happens, at the March meeting nominations for the 2009-2010 VFW year took place. At the April meeting, final nominations will be taken. Elections will then be conducted at the April meeting at the close of nominations.

Here is a summary of what is required of each of the elected positions and appointed positions in the VFW Post 5040. Any of these are open for those that would like to get involved this year. Of course, some people will volunteer again or be asked to retain their positions, but we always like to have people step up and volunteer for things like this as well. Is this your year to get involved and try something different and new?

Commander: (a) Preside at all meetings, (b) enforce laws of VFW, (c) conduct business and activities according to VFW standards (d) decide all questions of law (f) approve expenditures (g) assure QM is bonded (h) assure all dues are forwarded to Department (i) assure all reports are correct (j) assure all eligible veterans encouraged to join and maintain membership (k) assure that he or representative attend District Conventions (l) comply with and perform duties of VFW.

Sr. Vice: Assist Commander in preserving order and preside in absence of Commander.

Jr. Vice: Assist Commander in preserving order and preside in absence of Commander and Sr. Vice Commander.

Quartermaster: (a) receive and properly account for all monies and property in Post (b) pay our authorized payments (c) be bonded (d) collect monies giving re-

ceipts (e) keep dues accounts on members (f) collect annual membership dues (g) transmit dues to Department (h) refrain from issuing memberships until dues paid (i) maintain dues reserve (j) expend dues paid by Post on members form general fund (k) maintain relief fund (l) maintain books (m) deliver to successor all records (n) serve as treasurer in all committees (o) comply with all VFW laws.

Adjutant: (a) prepare all reports required of him (b) attest by signature all actions of the Post (c) keep in books: by laws, member applications, meeting minutes, orders from higher offices, correspondence file, proof of eligibility, roll of departed comrades (d) transfer all records to successor (e) comply with all VFW laws

<u>Chaplain:</u> Shall be chairman of visiting committee of Post. Visits sick and disabled members and make report to membership.

<u>Judge Advocate:</u> Gives commander legal assistance.

Surgeon: Chairman of Health committee. Shall promote and put into effect health programs for the benefit of the Post and community.

Officer of the Day: (a) Custodian of the Post colors, alter flag, Bible, ballot box, gavel and other such property (b) at the beginning of meeting, inspect membership card (c) have Post colors in position prior to meetings (d) at the close of meetings assures that all property is under his control (e) prepares ballots (f) carry out order of commander.

Trustees: (a) audit books and records of the Post (b) submit a Post trustees report of audit to Department QM (c) verify all expenditures (d) audit the records and accounts of all committees (e) perform duties that are incident to position.

Guard: (a) allow no one to enter meeting room who does not posses a dues receipt card or membership (b) notify Officer of the Day of all distinguished guests present (c) perform duties that are incident to position.

The Little League has four divisions this year: Rookie, Major, Minor and Junior leagues.

Service Officer: Assist members of the Post, widows, and orphans in obtaining rightful benefits from federal and state governments, preparing proper forms for applying for benefits, and assembling required evidence.

Assistant Adjutant: Assists Adjutant as requested.

Assistant Quartermaster: Assists Quartermaster as requested.

<u>Legislative</u> <u>Chairman:</u> Inform Post membership of all legislative information sent to him by Department or National.

Employment Chairman: Work for the accomplishment of the employment programs adopted by the National and Departmental conventions and Post to promote employment of veterans.

Public Relations Chairman: Publicize the activities of the Post which enhance the prestige of the Post and membership. He shall seek cooperation of local publications and broadcast media to obtain favorable publicity for the VFW of the US.

Americanism Chairman: Maintains record of all Patriotic Days and shall initiate programs for their proper observance by the Post and community.

Post Newsletter Editor: Responsible for creating newsletter format, editing written and pictorial content, organizing submitted content, producing electronic copy for print services, maintaining Post address list, printing address labels, tabbing and labeling newsletters, working with advertisers in ad development, renewal and changes, work with Post Office to qualify for bulk mail rates at pre-sort level.

Post Webmaster: Responsible for yearly renewal of domain name and web hosting service, updating web pages with content as needed, developing new web pages as needed, posting digital copy of newsletter to website, keeping maintenance costs to a minimum, answering email that comes through the website mailboxes. Basic knowledge of HTML, CSS, FTP is helpful.


The Woodstock VFW was one of the original sponsors of Woodstock Little League and continues to have a prominent role in this program for youths seven to 14 years of age.

You are at a parade, out of uniform, the American flag is coming your way. Hand over your heart or do you salute? What do you do when the National Anthem is played?

From the website of U.S. Senator Jim Inhofe, Oklahoma

October 14, 2008 WASHINGTON, D.C. - Today, U.S. Senator Jim Inhofe (R-Okla.) praised the President's signing of the National Defense Authorization Act of Fiscal Year 2009, which includes a provision to allow veterans and military members out of uniform to salute the flag during the National Anthem. Senator Inhofe sponsored the amendment to ensure veterans and all members of the Armed Forces be given the right to render a military salute to the United States flag. The National Defense Authorization Act of Fiscal Year 2009 was approved by unanimous consent in the Senate on Saturday, September 27, and was signed by President Bush today.

"With the President's signature today, we have finally revised the law to give veterans the proper distinction of saluting during the National Anthem," Senator Inhofe said. "The salute is a form of honor and respect, representing pride in one's military service. Veterans and service members continue representing the military services even when not in uniform. The U.S. Code is now consistent for veterans and all service members in regards to the symbolic gesture of the military salute.

"I believe this is an appropriate way to honor and recognize the 25 million veterans in the United States who have served in the military and remain as role models to other citizens. Those who are currently serving or have served in the military have earned this right, and their recognition will be an inspiration to others."

A provision championed by Senator Inhofe in the Defense Authorization Act for Fiscal Year 2008 modified Title 4 of the U.S. Code to allow veterans and military service members not in uniform to render the military salute during hoisting, lowering, or passing of the flag, but it did not allow them to salute the flag during the National Anthem. Section 595 of S. 3001 the National Defense Authorization Act for Fiscal Year 2009, amends Title 36 of the U.S. Code to allow veterans and service members not in uniform to salute the flag during the National Anthem, making the two sections of U.S. Code consistent




From the Editor's Desk

Our hearts and our prayers go out to the families of these soldiers. We are proud of your sons, your soldiers, our heroes.


To all our members, don't forget about the upcoming elections for the VFW officer positions for the 2009-2010 year. April is the month that we will elect new offi-
