# VFW used as staging area by Marine Corps League for soldier care package assembly

The Woodstock VFW was headquarters for many volunteers of the McHenry County Marine Corps League and its Auxiliary when they prepared 100 care packages to be sent to troops in Iraq. The care packages were sent to Lance Corporal Terry Sielken and Lance Corporal Stephen Davis in the last week of January.

Herb Zabrowski, Wonder Lake, a Marine on active duty from 1969 to 1971, is the Marine Corps League of McHenry County Commandant. Barbara Klapperich is the Marine Corps League Auxiliary president. Her father, Walter Kuck, was a Marine serving aboard the USS Lake Champlain during WWII. Klapperich said items are being boxed for mailing to the two men who will share the donations with others in their troop. The flat rate for each box is \$8.95 which represents the Marine Corps League's investment of several hundred dollars in postage. The League conducts fund-raising events through the year to finance its charitable activities.

Klapperich said many groups participated in collecting items for the care packages. First and second grade students at Ringwood Grade School, with the help of their teachers and parents, donated a collection of "goodies" that would fill a fam-

# Will Lightning Raffle be played at the VFW?

After the games of Lightning Raffle were played on February 9th, there was much interest in the possibility of future games to be played at the VFW.

Ralph Ritter, who ran the Lightning Raffle drawing for the Sweetheart Fun Night, has offered to look into the possibility of bringing this to the VFW on a more regular basis.

The Sweetheart Fun Night was more of a trial run to see what the reaction was to this game, if people liked or disliked it, etc. The cards that were used and played with on the Sweetheart Fun night were purchased from another organization within Woodstock that offers Lightning Raffle on a regular basis to only members of its organization.

With the help of Ralph Ritter, the Post is going to try to make this a reality. But it's going to take some work and one man alone cannot do it.

Some of you might think back to the days when Bingo was played at the Post until several years ago. The Bingo night required several people to work the floor selling cards, checking winning Bingo cards, ball caller, etc.

A similar setup will be required with the Lightning Raffle. Several volunteers will be needed to sell the raffle tickets before each game, collect the used tickets (for tracking purposes), validate winners, call the numbers, etc. The plan is to rotate number callers and have hopefully 4 groups so we can rotate it on a weekly basis so people don't have to work on this more than once a month.

At the last VFW meeting, it was mentioned that the proceeds from this raffle, should it be implemented, would go directly to the maintenance of the building. We have some major upkeep issues with the building that we still need to take care of that we need funds for.

Okay, so you're probably asking yourself about now, "Is it going to be played or not?" Well, that depends. There are certain regulations, both local and state, that govern this type of raffle and licenses that need to be obtained for organizations that run this raffle on a regular basis.

While the VFW is looking into the licensing, here are some thoughts around

how the game will likely be run which is a little different than the Sweetheart Fun Night. These are thoughts on how we think things will be run, but they may change depending on what the regulations dictate.

Games will be open to the general public, not just VFW Members. So anyone of legal gambling age can play. Five games will be played each week. For each game, a different deck of tickets will be sold which is color coded to differentiate the games. Colors available will be red, blue, orange, black, purple, yellow.

There are 150 cards to a deck and each ticket will be sold at \$1.00 each. For each round of play, the money is split three ways: 1/3 to each game's winner, 1/3 to the jackpot, 1/3 to the VFW Post 5040 Maintenance Fund.

Game play will be the same as the night of the Sweetheart Fun Night. There are 66 numbered white ping pong balls in the numbers drum, so numbers 1 through 66 will be drawn out of the drum one at a time. When someone crosses / checks off all three numbers on their raffle card, they will yell out "LIGHTNING" (not bingo) and the raffle is stopped to verify their card. The card will be verified for both the correct serial number for that game being played and that the winner has all three numbers called for that game.

The winner of that game will receive 1/3 of the money collected for that game, which can be up to \$50 if all the cards were sold for that game. After the winning ticket is verified, it will be announced to everyone that we have a winner for that game. The ticket sellers will then have to collect all losing tickets so they cannot be

used for another game.

Here's where things differentiate from the Sweetheart Fun Night. What normally happens in a Lightning game that makes winning even more interesting is the chance to win an even larger jackpot.

There is a 100 square jackpot board that has one winner hidden somewhere on it. The winner of the just played game will select a number on the jackpot board. In cases where there may be multiple winners for a single game, the winners must agree on one number on the jackpot board.

The number caller will open the number picked by that game winner(s). The game winner will announce to the rest of the players if they got the jackpot or if the pot rolls over.


If the square they picked says "WINNER / JACKPOT", they will receive the jackpot prize and a new 100 square jackpot board will be started for the next game's winner. With a 100 square jackpot board and only five games played per week, you can see how the jackpot can grow and quite possibly reach into the thousands of dollars to a single winner.

Tentatively the thought is to start games at 7 pm every Friday and end around 8:30 to 9 pm. The kitchen will be open till 7:30 in case someone wants to order dinner or appetizers.

So, the next steps are for the VFW Post 5040 to get the right permits or licenses in place before games are played.

## VFW Post 5040 nominations for 2008-2009 Officer posi- tions to be held over next several months

We are coming into that time of year when it's time to start thinking about our next year's officers and who will be leading our Post for the next year.

At the February meeting, VFW Judge Advocate, Dick Glawe, and 1 Year Trustee, Arnie Doerfert, were appointed as the VFW election officials for the upcoming VFW Elections. Election will take place at the April meeting.

As traditionally happens, at the March meeting nominations for the 2008-2009 VFW year will take place. At the April meeting, final nominations will also be taken. Elections will then be conducted at the April meeting at the close of nominations.

Does stepping up for an officer position interest you? Does your schedule allow you to devote some additional time this year to the VFW to help out in leading our Post? If it does, all it takes is a nomination and you can be in the running for one of these years officer positions.

Here is a quick summary of what is required of each of the positions in the VFW:

**Commander:** (a) Preside at all meetings, (b) enforce laws of VFW, (c) conduct business and activities according to VFW standards (d) decide all questions of law (f) approve expenditures (g) assure QM is

bonded (h) assure all dues are forwarded to Department (i) assure all reports are correct (j) assure all eligible veterans encouraged to join and maintain membership (k) assure that he or representative attend District Conventions (l) comply with and perform duties of VFW.

**Sr. Vice:** Assist Commander in preserving order and preside in absence of Commander.

**Jr. Vice:** Assist Commander in preserving order and preside in absence of Commander and Sr. Vice Commander.

**Quartermaster:** (a) receive and properly account for all monies and property in Post (b) pay our authorized payments (c) be bonded (d) collect monies giving receipts (e) keep dues accounts on members (f) collect annual membership dues (g) transmit dues to Department (h) refrain from issuing memberships until dues paid (i) maintain dues reserve (j) expend dues paid by Post on members from general fund (k) maintain relief fund (l) maintain books (m) deliver to successor all records (n) serve as treasurer in all committees (o) comply with all VFW laws.

**Adjutant:** (a) prepare all reports required of him (b) attest by signature all actions of the Post (c) keep in books: by laws, member applications, meeting minutes, orders from higher offices, correspondence file, proof of eligibility, roll of departed comrades (d) transfer all records to successor (e) comply with all VFW laws

**Chaplain:** Shall be chairman of visiting committee of Post. Visits sick and disabled members and make report to membership.

**Judge Advocate:** Gives commander legal assistance.

**Surgeon:** Chairman of Health committee. Shall promote and put into effect health programs for the benefit of the Post and community.

**Officer of the Day:** (a) Custodian of the Post colors, alter flag, Bible, ballot box,

gavel and other such property (b) at the beginning of meeting, inspect membership card (c) have Post colors in position prior to meetings (d) at the close of meetings assures that all property is under his control (e) prepares ballots (f) carry out order of commander.

**Trustees:** (a) audit books and records of the Post (b) submit a Post trustees report of audit to Department QM (c) verify all expenditures (d) audit the records and accounts of all committees (e) perform duties that are incident to position.

**Guard:** (a) allow no one to enter meeting room who does not possess a dues receipt card or membership (b) notify Officer of the Day of all distinguished guests present (c) perform duties that are incident to position.

**Service Officer:** Assist members of the Post, widows, and orphans in obtaining rightful benefits from federal and state governments, preparing proper forms for applying for benefits, and assembling required evidence.

**Assistant Adjutant:** Assists Adjutant as requested.


**Assistant Quartermaster:** Assists Quartermaster as requested.

**Legislative Chairman:** Inform Post membership of all legislative information sent to him by Department or National.

**Employment Chairman:** Work for the accomplishment of the employment programs adopted by the National and Departmental conventions and Post to promote employment of veterans.

**Public Relations Chairman:** Publicize the activities of the Post which enhance the prestige of the Post and membership. He shall seek cooperation of local publications and broadcast media to obtain favorable publicity for the VFW of the US.

**Americanism Chairman:** Maintains record of all Patriotic Days and shall initiate programs for their proper observance by the Post and community.

### Postal Service offers first-time military discount for new, large flat-rate box

WASHINGTON, February 6 / PRNewswire USNewswire--Planning to send a care package to a U.S. military service member serving abroad? Send it after March 3, 2008 to take advantage of a new flat-rate box from the U.S. Postal Service that is 50 percent larger and delivered for \$10.95 to an APO/FPO address -- \$2 less than for domestic destinations.

"This is the first time the Postal Service has offered a special price for our armed forces serving overseas," said Postmaster General John Potter. "We're proud that family and friends will be able to use this new larger-sized box to send much appreciated packages from home to our dedicated troops overseas."

The new Priority Mail Large Flat-Rate Box

(12" x 12" x 5 1/2" or 800 cubic inches) will be available in post offices nationwide beginning March 3, but customers can begin ordering them Feb. 20 at USPS or by calling 800-610-8734. Some of the new boxes are co-branded with the logo of America Supports You, which is a Department of Defense program that connects citizens offering support to the military and their families.

"It's terrific that the Postal Service continues to think of ways to help Americans support our troops and their families. Postage is always a concern when shipping care packages, and this new flat-rate box means our home-front groups and supportive citizens can do more with their resources," said Allison Barber, deputy assistant, Secretary of Defense. "We're especially pleased that some of the boxes will bear the America Supports You logo reminding our service members that they have our nation's support."

The \$2 discount is applied when the Priority Mail Large Flat-Rate Boxes are shipped to an APO/FPO destination. The two existing flat-rate boxes (11 7/8" x 3 3/8" x 13 5/8" and 11" x 8 1/2" x 5 1/2"), which currently retail for \$8.95 for U.S. addresses, are not available for the military discount. All flat-rate boxes can be used for international shipping.

The new flat-rate boxes will be available in post offices starting March 3. The America Supports You branded box will be available online, at select post offices near military bases, or by calling 800-610-8734.






