For some of you, its memories of many years of hard work put into the Post in days gone by. Some of us barely know any history of the Post and the people that made it possible.

BY THE PRESIDENT OF THE UNITED STATES OF MERICA A PROCLAMATION

More than two centuries ago, our Nation's Founders declared the birth of a new Nation and began an experiment in self-governance. The young Republic committed itself to protecting the rights of life, liberty, and the pursuit of happiness for all citizens. These ideals inspired loyalty to the young Nation and moved volunteers to fight for their independence.

Generations later, these founding principles continue to unify and command the loyalty of the American people. The United States has expanded in size, increased in population, and grown in diversity, yet the promise of liberty and the pursuit of happiness arouse the patriotism and loyalty of Americans anew. Just as early settlers pledged to do their part to build the new Nation, now recent immigrants -- loyal to the very same values -- are helping America fulfill its promise.

We enjoy these blessings of liberty only because brave patriots have answered the call of duty. The men and women of the United States Armed Forces exemplify loyalty to our highest ideals, as do those who have fought valiantly for civil rights within our borders. These Americans and many others have made enormous sacrifices, and our Nation is grateful for their selflessness and unshakeable loyalty.



Last chance for 2010-2011 VFW Post 5040 nominations; elections takes place this month

This is it. The meeting this month on April 19 will be the last chance to nominate yourself or another individual for an officer position.

At the March meeting, VFW Judge Advocate, Dick Glawe, accepted the following nominations for positions:

- Commander: **Brian Ritter**
- Sr. Vice: **Lawrence Gordon**
- Jr. Vice: **Robert James**
- QM: **Mark Freund**
- Chaplain: **Pete Lockinger**
- Judge Advocate: **Dick Glawe**
- Surgeon: **Harold Irwin**
- 3 Yr Trustee: **Open**
- 1 Yr Trustee: **Open**

At the April meeting, final nominations will be taken. Elections will then be conducted at the April meeting at the close of nominations.

Again, here is the listing and summary of what is required of each of the elected positions and appointed positions in VFW Post 5040. Officers are elected for a term of one year. Any of these positions are open for those that would like to get involved this year.

A correction from last month, some outdated information was used to indicate the elected positions. The updated elected officer positions are listed according to the General Orders, Section 217 of the National Manual of Procedure, as posted on the Department of Illinois website:

Commander (elected):

(a) Preside at all meetings, (b) enforce laws of VFW, (c) conduct business and activities according to VFW standards (d) decide all questions of law (f) approve expenditures (g) assure QM is bonded (h) assure all dues are forwarded to Department (i) assure all reports are correct (j) assure all eligible veterans encouraged to join and maintain membership (k) assure that he or representative attend District Conventions (l) comply with and perform duties of VFW.

Sr. Vice Commander (elected):

Assist Commander in preserving order and preside in absence of Commander.

Jr. Vice Commander (elected):

Assist Commander in preserving order and preside in absence of Commander and Sr. Vice Commander.

Quartermaster (elected):

(a) receive and properly account for all monies and property in Post (b) pay our authorized payments (c) be bonded (d) collect monies giving receipts (e) keep dues accounts on members (f) collect annual membership dues (g) transmit dues to Department (h) refrain from issuing memberships until dues paid (i) maintain dues reserve (j) expend dues paid by Post on members form general fund (k) maintain relief fund (l) maintain books (m) deliver to successor all records (n) serve as treasurer in all committees (o) comply with all VFW laws.

Chaplain (elected):

Shall be chairman of visiting committee of Post. Visits sick and disabled members and make report to membership.

Judge Advocate (elected):

Gives commander legal assistance.

Surgeon (elected):

Chairman of Health committee. Shall promote and put into effect health programs for the benefit of the Post and community.

Trustees (elected):

(a) audit books and records of the Post (b) submit a Post trustees report of audit to Department QM (c) verify all expenditures (d) audit the records and accounts of all committees (e) perform duties that are incident to position. (Trustees are elected for a term to three years.)

Adjutant:

(a) prepare all reports required of him (b) attest by signature all actions of the Post (c) keep in books: by laws, member applications, meeting minutes, orders from higher offices, correspondence file, proof of eligibility, roll of departed comrades (d) transfer all records to successor (e) comply with all VFW laws

Officer of the Day:

(a) Custodian of the Post colors, alter flag, Bible, ballot box, gavel and other such property (b) at the beginning of meeting, inspect membership card (c) have Post colors in position prior to meetings (d) at the close of meetings assures that all property is under his control (e) prepares ballots (f) carry out order of commander.

Guard:

(a) allow no one to enter meeting room

who does not posses a dues receipt card or membership (b) notify Officer of the Day of all distinguished guests present (c) perform duties that are incident to position.

Service Officer:

Assist members of the Post, widows, and orphans in obtaining rightful benefits from federal and state governments, preparing proper forms for applying for benefits, and assembling required evidence.

Assistant Adjutant:

Assists Adjutant as requested.

Assistant Quartermaster:

Assists Quartermaster as requested.

Legislative Chairman:

Inform Post membership of all legislative information sent to him by Department or National.

Employment Chairman:

Work for the accomplishment of the employment programs adopted by the National and Departmental conventions and Post to promote employment of veterans.

Public Relations Chairman:

Publicize the activities of the Post which enhance the prestige of the Post and membership. He shall seek cooperation of local publications and broadcast media to obtain favorable publicity for the VFW of the US.

Americanism Chairman:

Maintains record of all Patriotic Days and shall initiate programs for their proper observance by the Post and community.

Post Newsletter Editor:

Responsible for creating newsletter format, editing written and pictorial content, organizing submitted content, producing electronic copy for print services, maintaining Post address list, printing address labels, tabbing and labeling newsletters, working with advertisers in ad development, renewal and changes, work with Post Office to qualify for bulk mail rates at pre-sort level.

Post Webmaster:

Responsible for yearly renewal of domain name and web hosting service, updating web pages with content as needed, developing new web pages as needed, posting digital copy of newsletter to website, keeping maintenance costs to a minimum, answering email that comes through the website mailboxes. Basic knowledge of HTML, CSS, FTP, and CGI scripts is helpful.

What do those numbers above my name mean?

Question of the month: "On my address label there are some additional characters and I was wondering what they mean."

So, have you wondered what the extra letters and numbers mean? It's a cost savings measure that I have put in place. Above your label, you will notice that there is the endorsement "Change Service Requested" as well. We have a special account under ACS (Address Change Service, which a division of the US Postal Service - USPS) that allows us to receive change of address and other reasons for non-delivery electronically. In the past, when we specified "Return Service Requested", if something was wrong with the address, the newsletter physically came back to the Post with a new address or reason for non-delivery. The Post was then charged a first-class postage fee for each returned piece, whatever the going rate is for a first-class stamp (\$0.44 now) on top of the postage we already paid to mail it out.

With "Change Service Requested", the Post gets an electronic notification. What happens is that if there is a change of address or undeliverable message, instead of returning it to the Post, the USPS will **DISCARD** the mail piece and update a file as to why the mail piece was undeliverable. Once a month I download this file with address changes from the USPS. Usually it's 10 or fewer changes that I have to deal with. We are only charged \$0.26 per letter notification, about half of what a normal return would be. Since the newsletter is discarded, it's important to keep your address up to date. This way I can keep the Post mailing list current.

The alphanumeric string "BYBBKWZ" is the Post 5040 account number with ACS. Under this (between the "#" signs) is a unique identifier for each address that receives a mailed newsletter. It is a special



4-digit number that I track which ties back to the ACS electronic record. The digit after the second "#" is for pre-sorting purposes when I label the newsletters.

So you may be thinking, why bother to go through the extra work to save a few dollars a month? Two reasons. First, it's not cheap to mail our newsletter out and I look for ways to save mailing costs anywhere possible; second, the Post Office continually modifies how mail is handled and reclassifies discounts. I have to ensure that we take advantage of the lowest possible rates the USPS will give us.



In the next year or two, likely you will start seeing your label generated with a bar

code. When the USPS starts requiring bar code use in order for our Post to qualify for existing or lower rates, that's when I will start to change the label over. Right now it's not cost effective to do this because it involves using a larger label for the barcode, paying a small fee to certify our address list every few months, redesigning the address label, and software modification.

So, now you know a little more about your VFW newsletter address label.


